

COACH’S CODE OF CONDUCT & RESPONSIBILITY AGREEMENT

This Coach’s Code of Conduct & Responsibility Agreement (“Agreement”) outlines the expectations, standards, and responsibilities required of all coaches participating in any games, leagues, practices, or tournaments held at Impact Athletic Center.

All coaches must read, understand, and sign this agreement prior to coaching within the facility.

Professional Conduct

Coaches agree to:

- Conduct themselves in a professional, respectful, and sportsmanlike manner at all times.
- Demonstrate positive leadership and serve as a role model for athletes, spectators, and fellow coaches.
- Communicate respectfully with officials, staff, athletes, and spectators—no yelling, arguing, or inappropriate gestures.
- Accept and respect all decisions made by officials, security guards and Impact Athletic Center staff.
- Follow all facility rules, event rules, and tournament guidelines.

Athlete Supervision & Safety

Coaches agree to:

- Maintain full responsibility for the supervision, behavior, and safety of all athletes on their roster while inside the facility.
- Ensure athletes demonstrate sportsmanship, follow facility rules, and treat others respectfully.
- Ensure no athlete is left unattended before, during, or after games or tournaments.
- Remain on-site until all athletes in their care have been safely picked up or accounted for.

Facility Expectations

Coaches agree to:

- Keep all teams and players within designated areas of the facility.
- Ensure proper use of equipment, courts, and common spaces.
- Prevent team members from damaging property, interfering with other activities, or creating unsafe conditions.
- Immediately report any injuries, incidents, or facility concerns to Impact Athletic Center staff.

Zero Tolerance Behaviors

The following behaviors are strictly prohibited and may result in immediate removal from the facility, suspension, or coaching privileges being revoked:

- Verbal or physical abuse toward athletes, officials, spectators, staff, or other coaches.
- Encouraging unsafe or unsportsmanlike behavior.
- Use of profanity, threatening language, or aggressive behavior.
- Leaving athletes unsupervised or leaving the facility before all athletes are accounted for.
- Any behavior deemed harmful, unsafe, or unprofessional by facility management.

Compliance & Accountability

Coaches acknowledge that:

- Failure to adhere to this Agreement may result in disciplinary action, including suspension from coaching, removal from events, or loss of coaching privileges at the athletic center.
- Facility management has the authority to enforce these expectations at all times.
- This Agreement applies to all games, tournaments, practices, and special events held at the facility.

By signing below, I acknowledge that I have read, understand, and agree to abide by the Coach’s Code of Conduct & Responsibility Agreement. I understand that it is my responsibility to act professionally, ensure the safety and supervision of all athletes under my care, and remain in the facility until all athletes have been properly picked up or accounted for.
